- C) is entitled to Clubhouse privileges
- D) is entitled to all practice facilities
- E) is eligible for league play at their designated date of play
- F) has access to play Monday to Thursday & after 1:00 pm on Statutory Holidays.
- G) has access to play in all Club Tournaments.
- H) has 5 (five) days advance booking privileges commencing at 7:30 am

- B) between the ages 19-24 years of age as of September 1 of the playing year.
- C) in entitled to Clubhouse privileges
- D) is entitled to Gold playing privileges upon payment of the applicable dues.
- E) is entitled to practice facilities
- F) is eligible for league play
- G) has access to play in all Club Tournaments
- H) has 5 (five) days advance booking privileges commencing at 7:30 AM

**5 JUNIOR (ages 13 to 18 inclusive)**

All other persons between the ages of 13-18 as of September 1<sup>st</sup> of the playing year will be required to pay the Non Shareholder Junior membership fee.
- C) is entitled to clubhouse privileges.
- D) is entitled to golf playing privileges, with restrictions as determined by the Board from time to time and upon payment of the applicable dues.
- E) is entitled to free Driving Range privileges.

**6 JUVENILES (under 13)**

- A) is any person under 13 years of age as of September 1<sup>st</sup> of the playing year.
- B) is a son/daughter or grandchild of a current Playing Member or Seasonal Player who qualifies for the Shareholder Juvenile membership. All other persons under 13 years of age as of September 1<sup>st</sup> of the playing year will be required to pay the Non Shareholder Juvenile membership fee.
- C) is entitled to golf playing privileges with restrictions as determined by the Board, from time to time, and upon payment of applicable fees.
- D) is entitled to free Driving Range privileges.

**7 JUNIOR LEAGUE - Monday Nights Only (under 13)**

- A) open to all children between the ages of 6 - 18 years of age as of September 1st of the playing year.
- B) is a son/daughter or grandchild of a current Playing Member.
- B) is entitled to clubhouse privileges

**B. NON-PLAYING MEMBERS**

**1 SOCIAL MEMBER - 8-18 hole Rounds**

- D) is entitled to all practice facilities

- G) has three (3) days advanced booking privileges commencing 7:30 AM

The Board may, at their discretion, limit the number of members in this category to a maximum of one hundred (100) people. Written applications must be submitted **no later the February 28**. Those applications received after the deadline may not be reviewed nor considered for approval

An application requesting Social Membership must be submitted to the Board of Directors for Approval.

- E) is entitled to three (5) 18-hole rounds of golf per season and only valid for the year in which it was issued
- F) is not eligible for League Play or in Special Event
- G) has 3 (three) days advance booking privileges commencing 7:30 am

**Seasonal Player - A Seasonal Player is a Non-shareholder who:**

- A) has been approved and accepted as a seasonal player in the Club. (Upon fully completing the proper application form including credit card information, otherwise seasonal players are not allowed to have any charging privileges to their club account).
- B) has paid the annual dues for playing privileges, either for gold, silver or bronze
- C) is entitled to playing privileges, free driving range privileges and clubhouse privileges.
- D) is eligible for league play.
- E) is eligible to be the Club Champion or represent the Club as such.
- F) shall have no voting rights.
- G) shall have no right to, or any interest in, the property or effects of the club.

**E. CLUBHOUSE FOOD & BEVERAGE MINIMUM: GST Included**

Clubhouse Food & Beverage Minimum spending applies to all Gold, Silver, Bronze and Social Members.

The minimum Food & Beverage spending is **\$315.00** per member per playing season and is applicable to the following Members Classifications: Gold, Silver, Bronze and Social. If more than one of these members' classifications is billed to one account, the total of these fees may be incurred by any one of these members (i.e. if a husband and wife are under the same account number, the total fee of **\$630.00** may be incurred by either or both to total **\$630.00**), the fee must be spent by the end of the current playing season. Any portion of the Clubhouse Fee unspent as of the end of the current golfing season will be billed automatically to the same account number, the total fee of **\$630.00** may be incurred by either or both to total **\$630.00**).

Any portion of the Clubhouse Fee unspent as of the end of the current golfing season will be billed automatically to the members' account on the October Statement.

This past year, we have experienced a number of members who are not settling up their accounts in a timely manner. As a result the Board has requested that we institute the following policy. Members provide credit card information along with a signed form authorizing the Highwood Golf and Country Club to charge overdue amounts to this card if their account is not paid by the end of the following month. i.e. If the Statement date is March 31st, then you have until April 30th to pay your bill.
