①....The monthly dues for a business membership are \$350. Each additional employee adds \$100 per month to the monthly dues. Maximum of three additional employees.

②....The annual dues is determined by the months the member chooses at the time of signing up for the year. See chart on addendum B. A partial year member may choose to pay the annual dues on a 1/3, 1/3 and 1/3 payment plan. One third is due at sign-up with 1/3 due in 30 days and the final due at 60 days. The 30 day and 60 day payments will carry a 5% finance charge.

③....The food minimum is \$100 per quarter for the 2nd, 3rd and 4th quarters of the year for all resident and Social members. Business membership food minimum is \$150 per quarter for the 2nd, 3rd and 4th quarters. There is no food minimum for the first quarter of the year (Jan-Feb-Mar). If a member does not purchase \$100 worth of food within the quarter, the balance of \$100 minimum will be billed to the membership.

④....The annual power cart fee for partial year members will be calculated by the number of months the member chooses at a rate of \$45 per month for a single or \$60 per month for a family. This is an annual cart fee payable at the time of membership.

⑤....The monthly business membership cart fee is \$75 per month for the three principal players. The monthly fee will increase \$25 per month for each of the additional employee.

⑥....The Annual business membership cart fee is \$825 for the three principal players. The annual fee will increase \$250 for each additional employee up to the maximum 6 players.

⑦....To be eligible to pay the monthly rate for power carts, member must commit to one year's cart rental.
